28 **Abstract:**

29 This profile defines an extension element for use in attaching SAML attributes to an
30 <md:EntityDescriptor> or <md:EntitiesDescriptor> element, to communicate an
31 arbitrary set of additional information about an entity in its metadata.

32 **Status**

102 1 Introduction

103 The SAML V2.0 metadata specification [SAML2Meta] includes the `<md:Extensions>` element in
104 various places, including the `<md:EntityDescriptor>` and `<md:EntitiesDescriptor>` elements,
105 for use in extending the specification by carrying externally defined content. This profile defines such an
106 extension element, `<mdattr:EntityAttributes>`, as a container for one or more
107 `<saml:Attribute>` or `<saml:Assertion>` elements. It allows an arbitrary set of attribute information
108 to be carried within an entity's (or a group of entities') metadata to communicate additional information
109 about that entity (or group) to a metadata consumer.

110 1.1 Notation

111 This specification uses normative text.

112 The keywords "MUST", "MUST NOT", "REQUIRED", "SHALL", "SHALL NOT", "SHOULD", "SHOULD
113 NOT", "RECOMMENDED", "MAY", and "OPTIONAL" in this specification are to be interpreted as
114 described in [RFC2119]:

115 ...they MUST only be used where it is actually required for interoperation or to limit behavior
116 which has potential for causing harm (e.g., limiting retransmissions)...

117 These keywords are thus capitalized when used to unambiguously specify requirements over protocol
118 and application features and behavior that affect the interoperability and security of implementations.
119 When these words are not capitalized, they are meant in their natural-language sense.

147 2 SAML V2.0 Metadata Extension for Entity Attributes

148 2.1 Required Information

149 **Identification:** urn:oasis:names:tc:SAML:metadata:attribute

153 2.2 Profile Overview

154 SAML deployments and SAML-enabled applications often make extensive use of the
155 <saml:Attribute> element as a vehicle for carrying and consuming arbitrary structured information
156 about assertion subjects. This profile defines a metadata extension element as a container for one or
157 more such elements, or more generically for communicating a SAML attribute assertion. It allows attribute
158 information to be carried within an entity's (or a group of entities') metadata to communicate additional
159 information about that entity (or group) to a metadata consumer, much as an assertion can carry
160 attributes about a subject.

161 In some SAML deployments, metadata is often maintained and signed by a third party federation
162 operator, and this mechanism allows that operator to include extensible information (possibly signed by
163 still another party) about the federation's member sites, such as their adherence to optional federation
164 policies. Metadata consumers can then choose to process or ignore such information as they deem
165 necessary.

166 This profiles defines no specific attributes to be communicated, but additional profiles might leverage it to
167 do so.

168 2.3 Element <mdattr:EntityAttributes>

169 The <mdattr:EntityAttributes> element is a wrapper for one or more <saml:Attribute> or
170 <saml:Assertion> elements. Assertions that appear MUST conform to the profile in section 2.4, and
171 will contain only attribute statements. Relying parties MUST process assertions in accordance with the
172 standard processing rules in [SAML2Core].

173 If this element is used within the <md:Extensions> element of an <md:EntityDescriptor> element,
174 then it binds the enclosed SAML attributes (or the attributes within the enclosed assertions) to the
175 enclosing entity.

176 If this element is used within the <md:Extensions> element of an <md:EntitiesDescriptor>
177 element, then only <saml:Attribute> elements are to be used; <saml:Assertion> elements MUST
178 NOT be included. The enclosed attributes are bound to each <md:EntityDescriptor> within the
179 enclosing <md:EntitiesDescriptor> element.

180 The meaning of this element is undefined by this profile if it appears anywhere else within a metadata
181 instance, or within any other XML document.

182 Finally, this element MUST NOT appear more than once within a given <md:Extensions> element.

183 The following schema fragment defines the <mdattr:EntityAttributes> element:

191 **2.4 Assertion Profile**

192 All SAML assertions that appear in an `<mdattr:EntityAttributes>` element MUST conform to the
193 following restrictions:

- 194 ● The assertion's `<saml:Subject>` element MUST contain a `<saml:NameID>` element with a
195 Format of `urn:oasis:names:tc:SAML:2.0:nameid-format:entity`. The value of the
196 `<saml:NameID>` MUST correspond to the `entityID` of the enclosing
197 `<md:EntityDescriptor>` element.
- 198 ● The assertion's subject element MUST NOT include any `<saml:SubjectConfirmation>`
199 elements.
- 200 ● One (and only one) `<saml:AttributeStatement>` element MUST be included. Other
201 statement types MUST NOT be included.
- 202 ● The assertion MUST be independently signed (rather than inheriting a signature from the
203 metadata itself).

204 Apart from the above constraints, any other legal assertion content MAY be included, including the
205 `<saml:Conditions>` element and any conditions within it.

206 **3 Conformance**

207 **3.0.1 SAML V2.0 Metadata Extension for Entity Attributes**

208 A metadata producer conforms to this profile if it has the ability to produce extended metadata in
209 accordance with section 2.

210 A metadata consumer conforms to this profile if it can consume extended metadata in accordance with
211 section 2.
