
ETFs provide a similar taxation benefit as Mutual Funds

- The taxation of ETF is treated in the exact same way as Mutual Funds.
- For example in case of equity ETF, any gain will be will be classified as a short term capital gain, if held for less than 1 year and taxed at 15%.
- If these equity ETFs are held beyond, then it becomes a long term capital gain and is taxed at 10%.

All Mutual Fund investors have to go through a one-time KYC (Know Your Customer) process. Investors should deal only with Registered Mutual Funds (RMF).
