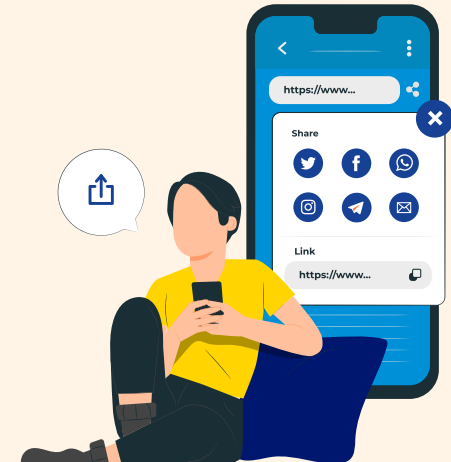

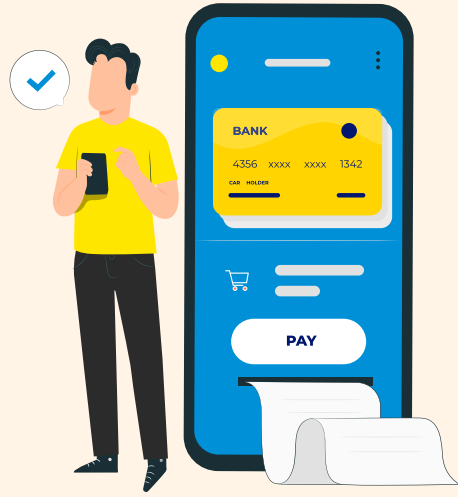
We collect your name, company name, identification number, date of birth, race, address, email address, and alternative contact details...

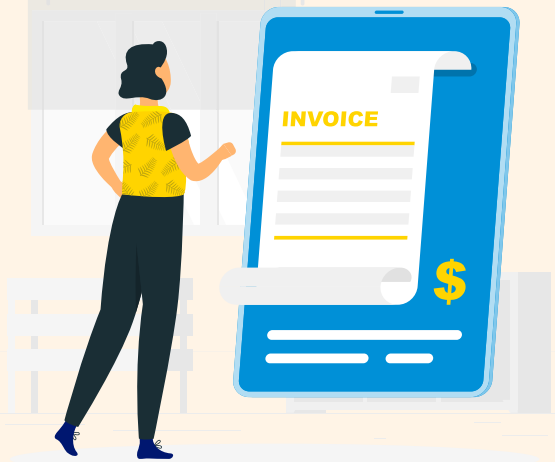

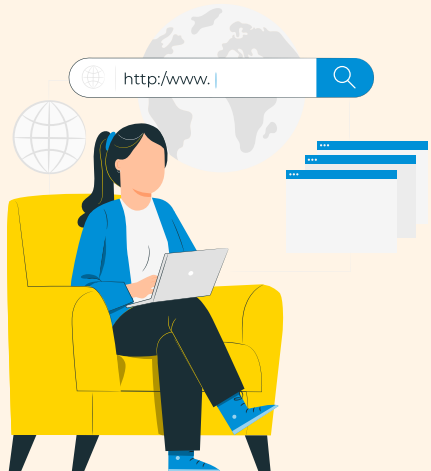
We collect your phone number, address, debit or credit card number, and billing information...

We collect your online browsing activities, IP address, device identifiers, and CCTV recording...



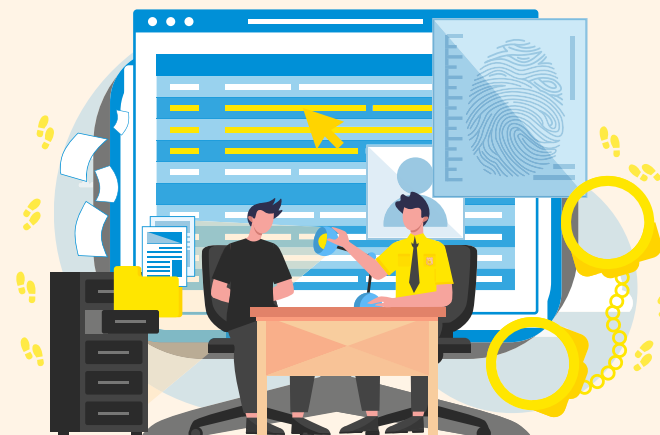

We share your personal data with our business partners to facilitate our services. When we do this, we ensure they practice good privacy standards.



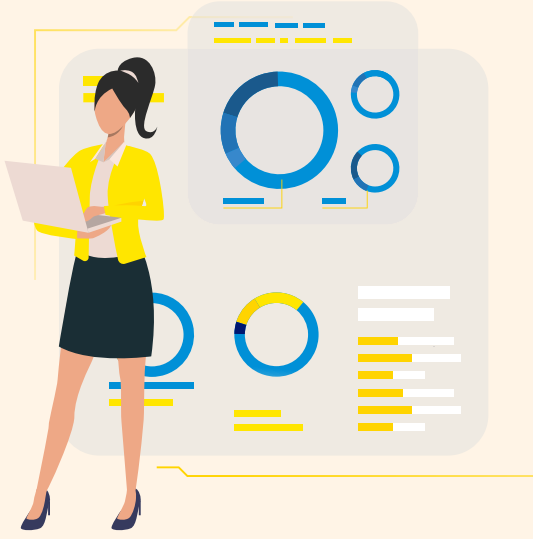
Sometimes, the authorities may also request for your personal data. When we do this, we ensure it is lawful and proportionate.
