

Question: Why is DIACAP still in the tool since it has not been valid for over 5 years now? Can it be removed?

Answer: DIACAP packages still exist. A new iteration of SNAP is being developed to remove old terms.

Question: Is SNAP required if you have an accredited system hosted in a commercial public cloud with no connection to DISN?

Answer: The policy is that all DoD circuits need to be registered.

Question: Do SNAP registrations need to be created per circuit per location?

Answer: Each circuit needs to be registered but the same ATO can be used?

Question: DIACAP should not be used in DoD, correct?

Answer: Yes, this is correct but DIACAP packages still exist.

Question: Who is responsible for ATO and ATC?

Answer: ATO is signed by the AO (with appointment letter) within the organization. The ATC is issued by the ATC.

Question: Are any of the DIACAP packages from DISA?

Answer: No

Question: Are very high and high ATC only for 6 months?

Answer: It is up to the AO to determine how the risk is managed. If they accept the risk then it will be honored.

Question: Are RMF controls being reduced?

Answer: No, the controls are not being reduced.

Question: Does every DoD system have to M/M/X?

Answer: It applies to all CUI systems.

Question: Are the required documents be rolled out to all eMASS instances?

Answer: The change will be per eMASS instant.

Question: Is eMass no longer the repository for uploading artifacts?

Answer: eMASS handles RMF and SNAP/SGS handle the Connection Approval process

Question: Is there a POC for our registrations in case there are questions if the submissions are rejected?

Question: Is there a standard format for the CSSP agreement?

Answer: Yes. SGS is for SIPRNet.

Question: Who is responsible for SAR, SAR testing and verifying the results?

Answer: The ISSM for the responsible organization.

Question: Are 3 year ATO's still granted?

Answer: Yes but they are rare.

Question: Does everything regarding the length of accreditation granted, Depend on the overall condition of the eMass/RMF package? or are there other circumstances that come into play?

Answer: That's the transactional path for data flow - the DoD PPSM process can help with that.

Question: Please list all the POAM document requirements, just mentioned, in the chat for everyone.

Answer: Topology, Consent to Monitor, ADD, CSSP Agreement

Question: What if we inherit the CSSP so we don't have an agreement with them?

Answer: You should still have access to the agreement. If you don't you can fill out the CSSP agreement template.

Question: Is the ISSM still responsible for Annual review of Security controls?

Answer: Yes

Question: Is DITPR still being utilized as a starting point for standing up?

Answer: It all depends on your security posture. Remember, your eMASS or RMF package is the documentation that you are compliant with the security requirements. It should reflect what you do.

Question: What if programs migrating to commercial cloud through a boundary point and are waiting for a waiver for a BCAP?

Answer: CNSSI is reviewing overlay prior to approving.

Question: Should I request all modules for a new SNAP account or on as needed access for ISSO access?

Answer: Request organizational level and the modules that you need.

Question: What is the CAO's deadline for uploading a renewal package?

Answer: The CAO reviews packages 5 business days from the submission date.

Question: Are there any common mistakes or issues that might cause denial?

Answer: CTM not signed by the AO

Question: If I begin the package upload process but its incomplete does that stop the disconnection clock?

Answer: It does not stop the disconnection clock since the ATC contains a specific date.
