SUBJECT: Approval of Revised Cyber Excepted Service Targeted Local Market Supplements

I approve the revised Cyber Excepted Service (CES) Targeted Local Market Supplement (TLMS) pay tables A2 through A9 for the following work roles: (212) Cyber Defense Forensics Analyst, (521) Cyber Defense Infrastructure Support Specialist, and (631) Information Systems Security Developer. The addition of these work roles will reduce pay disparities between the CES and the private sector, as well as improve the Department's overall recruiting and retention for these positions.

This approval also includes the addition of the following four new localities for coverage on TLMS tables A1 and A8: Fresno-Madera-Hanford, California; Reno-Fernley, Nevada; Rochester-Batavia-Seneca Falls, New York; and Spokane-Spokane Valley-Coeur d'Alene, Washington-Idaho. The new localities were made effective for General Schedule positions on January 14, 2024 by the Office of Personnel Management and are now being established for CES TLMS tables to provide continuity of coverage for employees who had been previously covered on these same tables under the "Rest of United States" locality.

The attached TLMS tables are approved and will be effective the first day of the first pay period beginning on or after the date of this memorandum. The CES TLMS will be reviewed annually by the Office of the DoD Chief Information Officer Workforce Innovation Directorate to ensure the rates are still necessary to meet mission requirements. Eligibility is determined by the incumbents' current status within CES and their primary work roles having been coded as roles that are covered and in an applicable locality. Adjustments to CES TLMS rates are made in accordance with Department of Defense Instruction 1400.25, Volume 3006, "DoD Civilian Personnel Management System: Cyber Excepted Service (CES) Compensation Administration."
