A meeting of National Preparatory Committee (NPC) for WRC-23 was held under the Chairmanship of Shri. V.J. Christopher, Wireless Adviser, WPC Wing at Sanchar Bhawan on 28th February 2023 at 1630 Hrs. to discuss the outcomes of APG23-5 meeting held during 2025 Feb 2023 at Korea Busan.

3. At the outset, the NPC Chairman welcomed all the participants and invited the concerned officers from the NPC Working Groups, that attended the APG23-5 meeting, to present the outcomes of the meetings.

The NPC Working Group presented in detail the APT Preliminary views developed for each WRC-23 Agenda Item during the APG23-5 meeting and also briefed the meeting on the important issues related to various WRC-23 Agenda Items discussed in the APG23-5 meeting. These issues were deliberated in the meeting and view point/suggestions of the participants were duly noted.
5. The meeting concluded that the India's Preliminary Views submitted to the APG23-5 has largely been incorporated in the APT Preliminary Views agreed at the meeting.

The NPC Chairman appreciated the efforts put in by the delegation to the APG23-5 meeting to ensure that the preliminary views of the APT formulated during the meeting are aligned with the preliminary views submitted by India. Further, the Chairman advised the NPC Working Groups to take into account the discussions, that happened during the APG23-5 meeting & during this meeting, while formulating the India views for the next APG23 meeting (APG23-6).
