**DECISION OF THE REPRESENTATIVES OF THE GOVERNMENTS OF THE MEMBER STATES,  
MEETING WITHIN THE COUNCIL,**

**of 30 November 2006**

**adapting Decision 96/409/CFSP on the establishment of an emergency travel document, in order to  
take account of the accession of Bulgaria and Romania to the European Union**

(2006/881/CFSP)

THE REPRESENTATIVES OF THE GOVERNMENTS OF THE MEMBER STATES OF THE EUROPEAN UNION, MEETING WITHIN THE COUNCIL,

Whereas:

It is necessary to make certain adaptations to Decision 96/409/CFSP<sup>(1)</sup>, in order to take account of the accession of Bulgaria and Romania to the European Union,

HAVE DECIDED AS FOLLOWS:

*Article 1*

Decision 96/409/CFSP shall be amended as follows:

(a) the following shall be added to Annex I after 'PRÍLOHA I':

(b) the following shall be added to Annex I after 'EURÓPSKA ÚNIA':

(d) the following shall be added to Annex I after 'ÚDAJE':

'ЗАДЪЛЖИТЕЛНИ ДАННИ/GLOSAR';

(e) the following shall be added to Annex I after '(13) Pečiatka vydávajúceho':
