Dear Mr. French:

We are writing to request information related to Lieutenant General Michael Flynn's speaking engagements and appearances arranged through your company that may have been paid for by, or on behalf of, foreign governments or their agents in violation of the U.S. Constitution.

The Emoluments Clause of the Constitution prohibits any person "holding any Office of Profit or Trust" from accepting gifts or payments from any foreign government or agent without the consent of Congress.¹ The Department of Defense has made clear that this Constitutional provision applies to retired military officers, such as Lieutenant General Flynn, because they continue to hold offices of trust.² It also applies to "indirect[]" sources of payments, including payments made through intermediaries in the United States.³

Lieutenant General Flynn has publicly acknowledged that he was paid on at least one occasion to travel to Moscow and speak at a gala hosted by RT, the Kremlin-backed media outlet.⁴ He has also stated that this paid speaking engagement was arranged through your company.⁵

We are attempting to determine the amount Lieutenant General Flynn received for his appearance, the source of the funding, and whether he may have received payments from any other foreign sources for additional engagements.

On February 14, 2017, the Secretary of the Army informed our Committee that after a "thorough records search," the Department "has not found any documents" indicating that Lieutenant General Flynn requested permission for his speaking engagement with RT in December 2015 or reported the payments he received, as required by Defense Department regulations to comply with the Constitution.⁶

To assist the Committee's investigation of this matter, please provide the following documents and information as soon as possible, but no later than March 2, 2017:

- 1. all documents and communications relating to Lieutenant General Flynn's appearance at the event in Moscow in December 2015, including who or what entity requested Lieutenant General Flynn, who or what entity paid for Lieutenant General Flynn's appearance, any negotiations relating to Lieutenant General Flynn's compensation, and the compensation paid to Lieutenant General Flynn and your company for his appearance, travel, lodging, and other expenses;
- 2. all documents and communications relating to any other speaking engagements or appearances made by Lieutenant General Flynn in connection with RT, any agent or affiliate of RT, or any agent or instrumentality of the Russian government;
- 3. a list of all speaking engagements or appearances made by Lieutenant General Flynn, including the amounts of payment and sources of funding to your company and Lieutenant General Flynn for those speaking engagements; and
- 4. Lieutenant General Flynn's engagement contract with Leading Authorities, Inc.

The Committee on Oversight and Government Reform is the principal oversight committee of the House of Representatives and may at "any time" investigate "any matter" as set forth in House Rule X.

Please deliver your responses to the Majority Staff in Room 2157 of the Rayburn House Office Building and the Minority Staff in Room 2471 of the Rayburn House Office Building. The Committee prefers to receive all documents in electronic format. An attachment to this letter provides additional instructions for responding to the Committee's requests. Please note that Committee Rule 16(b) requires counsel representing an individual or entity before the
