Letter from the CEO

As President and CEO of PIR, it gives me great pleasure to report that 2023 was another wonderful year for the organization.

Significantly, we reached another milestone with the celebration of the fifth anniversary of the .ORG Impact Awards! In that time, we have recognized nearly 200 .ORGs that are doing amazing things to help their communities and make lasting impacts. We were especially proud to welcome the award category finalists, nonprofit partners, and industry guests to a gala celebration in Washington, DC-our first inperson assemblage since the inaugural event in 2019. The .ORG Impact Awards remain our premier way to showcase and honor so many great organizations and individuals that are helping to make the world a better place.

We also take pride in our ongoing efforts to mitigate DNS Abuse (i.e., various technical abuses of the Domain Name System, such as malware, botnets, and phishing). This subject remains a highly visible concern for our industry and we are very serious about our responsibility to do all we can about it. We are proud that .ORG remains the least abused of all the comparable domain extensions, but our commitment on DNS Abuse goes beyond just our own domains. We were proud to help drive changes to the contracts that bind all ICANN-accredited registries and registrars to include stricter anti-abuse obligations. Furthermore, PIR established the DNS Abuse Institute in 2021, and it continues to provide free tools like NetBeacon and Compass to report and quantify the incidence of such abuses at the registry and registrar level. Our growing support of and partnership with the Internet Watch Foundation helps to thwart Child Sexual Abuse Material throughout the Internet. We believe that all of these efforts help to foster a cleaner online environment, build more trusted namespaces, and support a safer Internet.



Importantly, we did all of these things while meeting our financial commitments to support the Internet Society and the Internet Society Foundation in pursuit of their charitable work across the globe. This is our reason for being, and we embrace it fully. Of course, it's very satisfying to consistently surpass such expectations. In fact, we've exceeded our budgeted contributions to the Internet Society in each of the past five years.

We do these things because it's core to our mission and how we want to operate. But don't just take my word for it: these efforts have not gone without notice. In addition to praise from industry colleagues, government, and law enforcement representatives for our DNS Abuse activities, we also received third-party recognition for our culture. Certifications by Fortune magazine and Great Place to Work confirm our efforts to live out our Core Values

consistent with our mission.

- My past five years at PIR have been an incredible journey. I'd like to thank all the PIR staff, Board, Advisory Council, customers, vendors, and everyone who is part of the .ORG Community for all of your support. PIR is considered the high standard by which others should be measured. It is an honor and privilege to be a part of and lead this exemplary organization.

Who We Are

.ORG is the original generic top-level domain (gTLD, domains that can be registered by entities or individuals worldwide for any reason) intended for mission-driven organizations. Since its inception in July 1985, .ORG has served as a platform for those who seek to make the world a better place. .ORG is where social good missions can thrive online. Furthermore, .ORG has created a lasting legacy of trust by advocating for an open and secure Internet where different communities can create a reliable online identity and freely exchange ideas. With over 10.8 million domain names registered across the globe, .ORG is the domain of choice for individuals and organizations committed to advancing the public interest.

PIR'S MISSION STATEMENT

To be an exemplary domain name registry and industry thought leader providing a trusted digital identity and serving as a valued resource to those working to improve our world.

Organizations, foundations, clubs, grassroots movements, associations, and individuals all choose .ORG to propel their causes forward. We've even seen for-profit ventures using .ORG to support their philanthropic endeavors. They opt for .ORG not just as a digital identifier, but also as a collective declaration of the societal significance of their endeavors. This diverse array of local, national, and global communities encompasses the .ORG Community, and collectively they make a positive impact on the world.

.ORG remains the centerpiece of our offerings, but it is not the only gTLD that we operate. In 2014, we also began offering new Internationalized Domain Names (IDNs, which are presented in non-Latin scripts so their users can operate online in their own language), versions of .ORG that mean "organization", "org", or "institution" in Devanagari (Hindi), Russian Cyrillic, and simplified Chinese. Then, in 2015 we launched .NGO and .ONG, two new TLDs for non-governmental organizations seeking a distinct domain to showcase their missions. In 2022, we added .CHARITY, .FOUNDATION, .GIVES, and .GIVING to our portfolio. These TLDs further empower mission-driven organizations to connect with their communities in unique ways and advance positive change in the world. Collectively, we refer to our TLDs as PIR's .ORG Family of Domains.

The .ORG Family of Domains have purpose—each TLD we manage is intended for good. From for-profit businesses launching a corporate social responsibility initiative, to mission-driven social enterprises, to nonprofit organizations large and small, PIR remains committed to providing the trusted digital identities that help those working to make a positive impact in the world.

PIR proudly manages the .ORG Family of Domains, and will continue to strive to be an exemplary registry operator and support the mission-driven entities—small grassroots movements, large associations, and everything in between utilizing these domains to promote their causes.

We take great pride in the fact that, like many in the .ORG Community, PIR itself is also mission-driven. Pursuant to our registration under the United States tax code as a 501(c)(3) organization, our mandate includes operating the gTLDs entrusted in our care in an exemplary manner, while also supporting the .ORG Community with resources and tools to be successful.

PIR is a "supporting organization" of our founder and sole member, the Internet Society. This means that PIR's contributions help the Internet Society—which is a global charitable nonprofit organization—achieve its important mission of working to ensure that the Internet remains a force for good for everyone as it works to build, promote, and defend a bigger and stronger Internet.¹

We also support the Internet Society Foundation, a separate U.S. 501(c)(3) organization. Established in February 2019, the Internet Society Foundation funds initiatives that strengthen the Internet in function and reach so that it can effectively serve all people. The Internet Society Foundation's mission is to champion ideas and enable communities to unlock the Internet's potential to tackle the world's evolving challenges.²

PIR is very proud of the part that we play in sustaining the Internet Society's and PIR's shared vision. Even with the worst aspects of the global pandemic behind us, the world faces a myriad of international crises and the need for mission-driven organizations remains clear. What We Achieved

PIR is pleased to report that once again, we achievedif not exceeded—our goals for 2023. We are especially proud that the .ORG Impact Awards (OIAs) celebrated its fifth anniversary. The OIAs celebrate and honor .ORGs across seven different categories that are making a difference in their communities and around the world. We also take pride in having met our 2023 financial goals. This means we were able to fully support the Internet Society and Internet Society Foundation with their important missions, and also engage the .ORG Community consistent with our mission. Meanwhile, there were important developments in the fight against DNS Abuse, and you'll see that our robust anti-abuse metrics and leadership on these issues-not least through the work of the DNS Abuse Institute-continue to demonstrate our commitment to operating as an exemplary registry. Finally, our efforts to foster a culture of excellence were once again recognized by leading external assessors.

REGISTRY SERVICE PROVIDER CONFIRMED

Throughout 2023 PIR managed a comprehensive evaluation process to identify the entity that will provide support during the coming years for all of our TLDs, including .ORG, .CHARITY .FOUNDATION, .GIVES, .GIVING, .NGO, .ONG, .OPR, .संगठन , and .机 构. Ultimately, we selected Identity Digital, our incumbent provider. The parties executed an agreement in October, the terms and conditions of which are subject to confidentiality provisions.

2023 .ORG Impact Awards

2023 was a milestone year for PIR as we celebrated the fifth anniversary of our .ORG Impact Awards (OIAs). Since the inception of the OIAs in 2019, we have recognized almost 200 missiondriven organizations and individuals with a connection to a .ORG domain. All of the category finalists and winners are outstanding examples of the extraordinary things that people with passion and motivation, regardless of any resource limitations or other challenges that they may face, can do to uplift their communities and make an impact around the world.

Furthermore, the 2023 OIAs were the first in-person gathering since our inaugural showcase in 2019. Therefore, we wanted to make it a bigger and better celebration than ever. With almost 1,000 .ORGs from over 70 countries applying in 2023, we welcomed an incredible group of over 200 finalists, nonprofit partners,

The category winners received donations of \$10,000 and all finalists received donations of \$2,500 and travel and accommodations for two representatives to attend the awards ceremony, which was hosted by Padma Lakshmi, activist, author, and host/producer of Hulu's Taste the Nation. It was a fitting celebration for some very special entities working to make the world a better place.

In 2023, the OIAs recognized changemakers across seven categories:

Of course, we also honored the .ORG of the Year. Selected by PIR from the finalist pool, this award recognizes an organization or individual for their timely commitment to tackling a critical issue facing the community and their success in doing so. The 2023 .ORG of the Year was UK-based Hope for Justice, which exists to bring an end to modern slavery by preventing exploitation, rescuing victims, restoring lives, and reforming society. With 350 staff based in over a dozen offices across four continents, this organization touched the lives of over 200,000 people last year alone. Hope for Justice's vision is to live in a world free from slavery, and every step of the journey towards achieving this ambition is empowered by a global movement of supporters, campaigners, donors, fundraisers and freedom-bringers. As the .ORG of the Year, Hope for Justice received a total donation of \$50,000.





Fundamentally, that entails supporting and promoting the development of the Internet as a global technical infrastructure, a resource to enrich people's lives, and a force for good in society. This has included projects focused on the real or potential impacts of the Internet on our society, the environment, and in response to natural disasters or other emergency situations. Our success continues to be driven by strong domain registration and renewal volumes, particularly in .ORG. In fact, we continued to post year-over-year growth in new registrations-no small feat considering the size of our base of names-and our overall renewal rates remained at over 80 percent! We believe that these results directly reflect our strategy to focus on responsible growth that prioritizes quality names, i.e., ones more likely to renew because they are providing value and are not being used for abusive purposes. Our Quality Performance Index (QPI) program has played a significant part in this success. As noted in our previous Annual Reports, QPI was launched in May 2019 to help promote a more healthy domain system by encouraging responsible registrations in .ORG while taking proactive steps to reduce DNS Abuse. By providing registrars with incentives to promote quality domain names, the program helps reduce instances of domain name abuse and improve trust in .ORG—with measurable financial benefits for both the registrar and the registry. Anti-Abuse **Efforts**

For over two decades, PIR has proudly operated .ORG as an exemplary nonprofit registry. In part, that means that we do all that we can to support a free, open, and safe Internet. We appreciate that a lot of trust has been placed in us, and we'll always operate .ORG and the other TLDs under our care in the public interest.

With regards to safety, though, a persistent concern across our industry is DNS Abuse. This is defined as technical abuses of the DNS like phishing, pharming, malware, botnets, and spam when it serves as a delivery mechanism for these abusive activities. We also maintain programs to address certain categories of abuses that fall outside of that definition. Specifically, PIR's anti-abuse efforts also address narrowly scoped website content abuses such as Child Sexual Abuse Materials (CSAM), the online distribution of opioids or narcotics, and imminent threats to human safety. All of these abuses cause real harm for their victims and undermine trust in the Internet.

PIR remains fully committed to combating DNS Abuse. Consistent with our Anti-Abuse Principles and through rigorous enforcement of our <u>Anti-Abuse Policy</u>, we're proud to say that we manage the cleanest large gTLD namespace. We devote significant resources to our internal abuse monitoring efforts and have forged strong relationships with select trusted notifiers who work with us to identify and take down abusive domains across our name spaces. We recognize that acting responsibly also requires a commitment to due process, which is why we maintain an Appeals Process for our Anti-Abuse Program, which is unique in the gTLD space. While the work is never done, we're proud of our ongoing anti-abuse efforts.

Key Partners in Fighting Abuse

In addition to Identity Digital, our Registry Service Provider, and CleanDNS, whose platform utilizes an evidence-based workflow to simplify and accelerate domain abuse mitigation procedures, PIR also leverages other organizations' expertise to more effectively fight DNS Abuse.

- Over the last five years PIR has worked with the Internet Watch Foundation (IWF) to root out instances of CSAM on our namespaces. Based in the UK, this not-for-profit organization works globally to stop child sexual abuse imagery on the Internet. CSAM is a particularly difficult problem to mitigate given the various laws and regulatory frameworks governing its identification and removal. Nevertheless, we strongly support IWF's efforts and announced a major collaboration with them for 2024.
- In June 2023, we announced a partnership with the American <u>Red Cross</u> intended to disable domains in our TLDs that exploit the name and likeness of the Red Cross in order to deceive unsuspecting donors in the wake of natural disasters or humanitarian crises in the U.S. and around the world. This trusted notifier relationship builds upon the years' long online safety commitment of the American Red Cross to protect the public from fraud and scams. Importantly, this partnership is consistent with PIR's Anti-Abuse Principles as it takes care to respect freedom of expression and includes an appeals mechanism to ensure registrant due process.

Consistent with our **Anti-Abuse Principles** and through rigorous enforcement of our Anti-Abuse Policy, we're proud to say that we manage the cleanest large gTLD namespace.

All of this initiative continues to earn the Institute accolades from industry, civil society, academic, government and law enforcement representatives.

One of the clearest ways that PIR demonstrates its commitment to fighting DNS Abuse and living up to our Mission Statement is through the work of the recently renamed NetBeacon Institute ("the Institute"). PIR launched the Institute in early 2021 to develop recommended best practices, create industry-shared solutions, and foster collaboration in the fight against DNS Abuse. The Institute's flagship offerings-NetBeacon Reporter, a centralized solution that helps the community report DNS Abuse to the appropriate registrar, and NetBeacon Measurement and Analytics Platform (MAP), impartial reporting that tracks abusive activity and concentrations across the DNS and at specific TLDs and registrar-provide free tools to combat DNS Abuse. All of this initiative continues to earn the Institute accolades from industry, civil society, academic, government and law enforcement representatives. ICANN CONTRACTS UPDATED TO ADDRESS DNS ABUSE

A potentially critical tool in the fight against DNS Abuse is diligent enforcement of the contracts that ICANN has with every gTLD Registry and Registrar. Unfortunately, some of the terms in those agreements were ambiguous or hard to enforce—until recently. In late 2022, representatives of leading gTLD registries and registrars—including PIR's Chief Legal and Policy Officer and our Senior Director of Policy, who also serves as Vice Chair of the Registries Stakeholder Group-helped shepherd a negotiation process with ICANN to strengthen key anti-abuse provisions of their contracts. In about a year-record time for what typically can be a slowermoving process—those terms were hammered out and approved. Combined with reporting from a trusted source like the Institute, ICANN should now be better positioned to identify problematic contractual parties, enforce compliance, and help mitigate DNS Abuse.

As you can see, we're proud of everything we do to combat DNS Abuse. 


