## INFORMATION ABOUT THE VIRGINIA REGISTER OF REGULATIONS

## VIRGINIA REGISTER

The Virginia Register is an official state publication issued every other week throughout the year. Indexes are published quarterly, and the last index of the year is cumulative.

The Virginia Register has several functions. The full text of all regulations, both as proposed and as finally adopted or changed by amendment are required by law to be published in the Virginia Register of Regulations.

In addition, the *Virginia Register* is a source of other information about state government, including all Emergency Regulations issued by the Governor, and Executive Orders, the Virginia Tax Bulletin issued monthly by the Department of Taxation, and notices of all public hearings and open meetings of state agencies.

# ADOPTION, AMENDMENT, AND REPEAL OF REGULATIONS

An agency wishing to adopt, amend, or repeal regulations must first publish in the Virginia Register a notice of proposed action; a basis, purpose, impact and summary statement; a notice giving the public an opportunity to comment on the proposal, and the text of the proposed regulations.

Under the provisions of the Administrative Process Act, the Registrar has the right to publish a summary, rather than the full text, of a regulation which is considered to be too lengthy. In such case, the full text of the regulation will be available for public inspection at the office of the Registrar and at the office of the promulgating agency.

Following publication of the proposal in the Virginia Register, sixty days must elapse before the agency may take action on the proposal.

During this time, the Governor and the General Assembly will review the proposed regulations. The Governor will transmit his comments on the regulations to the Registrar and the agency and such comments will be published in the Virginia Register.

Upon receipt of the Governor's comment on a proposed regulation, the agency (i) may adopt the proposed regulation, if the Governor has no objection to the regulation; (ii) may modify and adopt the proposed regulation after considering and incorporating the Governor's suggestions, or (iii) may adopt the regulation without changes despite the Governor's recommendations for change.

The appropriate standing committee of each branch of the General Assembly may meet during the promulgation or final adoption process and file an objection with the Virginia Registrar and the promulgating agency. The objection will be published in the Virginia Register. Within twenty-one days after receipt by the agency of a legislative objection, the agency shall file a response with the Registrar, the objecting legislative Committee, and the Governor

When final action is taken, the promulgating agency must again publish the text of the regulation, as adopted, highlighting and explaining any substantial changes in the final regulation. A thirty-day final adoption period will commence upon publication in the *Virginia Register*.

The Governor will review the final regulation during this time and if he objects, forward his objection to the Registrar and the agency. His objection will be published in the Virginia Register. If the Governor finds that changes made to the proposed regulation are substantial, he may suspend the regulatory process for thirty days and

require the agency to solicit additional public comment on the substantial changes.

A regulation becomes effective at the conclusion of this thirty-day final adoption period, or at any other later date specified by the promulgating agency, unless (i) a legislative objection has been filed, in which event the regulation, unless withdrawn, becomes effective on the date specified, which shall be after the expiration of the twenty-one day extension period; or (ii) the Governor exercises his authority to suspend the regulatory process for solicitation of additional public comment, in which event the regulation, unless withdrawn, becomes effective on the date specified which date shall be after the expiration of the period for which the Governor has suspended the regulatory process.

Proposed action on regulations may be withdrawn by the promulgating agency at any time before final action is taken.

#### **EMERGENCY REGULATIONS**

If an agency determines that an emergency situation exists, it then requests the Governor to issue an emergency regulation. The emergency regulation becomes operative upon its adoption and filing with the Registrar of Regulations, unless a later date is specified. Emergency regulations are limited in time and cannot exceed a twelve-months duration. The emergency regulations will be published as quickly as possible in the Virginia Register.

During the time the emergency status is in effect, the agency may proceed with the adoption of permanent regulations through the usual procedures (See "Adoption, Amendment, and Repeal of Regulations," above). If the agency does not choose to adopt the regulations, the emergency status ends when the prescribed time limit expires.

## **STATEMENT**

The foregoing constitutes a generalized statement of the procedures to be followed. For specific statutory language, it is suggested that Article 2 of Chapter 1.1:1 (§§ 9-6.14:6 through 9-6.14:9) of the Code of Virginia be examined carefully.

# DEPARTMENT OF THE TREASURY AND TREASURY BOARD

<u>Title of Regulation:</u> VR 640-01. Public Participation Guidelines for the Department of the Treasury and Treasury Board.

<u>Statutory</u> <u>Authority</u>; §§ 2.1-180, 2.1-364, 55-200.1 and 55-210.27 of the Code of Virginia.

<u>Public Hearing Date:</u> June 19, 1986 - 10 a.m. (See Calendar of Events section for additional information)

#### Summary:

The Virginia Department of the Treasury and the Treasury Board's Public Participation Guidelines will be used to solicit and promote the participation of all interested and affected parties in the development, formulation and adoption of such regulations as the department and the board may promulgate under the authority established by state law.

VR 640-01. Public Participation Guidelines for the Department of the Treasury and Treasury Board.

## § 1. Generally.

In developing any regulation which they propose, the Department of the Treasury or Treasury Board (collectively, "department") are committed to soliciting input and comment from interested citizens, professional associations, and industry associations. Such input and participation shall be actively solicited by the department.

Any person who is interested in participating in the regulation development process should immediately notify the department in writing. Such notification of interest should be sent to Agency Regulatory Coordinator, Department of the Treasury, P.O. Box 6-H, Richmond, Va. 22215

## § 2. Identification of interested parties.

Prior to the development of any regulation, the department shall identify persons whom it feels would be interested in or affected by the proposal. The methods for identifying interested parties shall include, but not be limited to, the following:

I. Obtaining annually from the Secretary of the Commonwealth a list of all persons, citizen groups, associations and others who have registered as

lobbyists for the annual General Assembly session. This list will be used to identify interest groups which may be interested in the subject matter of the proposed regulation;

- 2. Utilizing the statewide listing of business, professional, civic and charitable associations and societies in Virginia published by the State Chamber of Commerce to identify additional industry and professional associations which might be interested in the regulation;
- 3. Utilizing department subject matter files to identify persons who have previously raised questions or expressed an interest in the subject matter under consideration through requests for rulings or information; and
- 4. Utilizing a standing list, compiled by the department, of persons who have previously participated in public proceedings relative to similar subject matters who have expressed an interest in all Treasury regulations.

#### § 3. Notification of interested parties.

## A. Generally.

The department shall prepare a Notice of Intended Regulatory Action prior to the development of any regulations. The notice shall identify the subject matter and purpose for the development of the new regulation(s) and shall specify a time deadline for receipt of responses from persons interested in participating in the development process.

## B. Dissemination of notice.

The methods for disseminating the notice to the public shall include, but not be limited to, the following:

- 1. Sending notice to all persons identified (pursuant to subdivision 2 of § 2 above) as having a potential interest in the regulation;
- 2. Publishing notice in the <u>Virginia Register of Regulations</u>; and
- 3. Requesting that industry, professional and citizen associations to whom the notice is sent publish such notice in newsletters or journals or use any other means available to them to disseminate the notice to the membership.

## § 4. Public participation.

## A. Regulation development.

- I. Initial comment. After interested parties have responded to the notice, the department will analyze the level of interest. If sufficient interest exists, the department may schedule informal meetings prior to the development of any regulation to determine the specific areas of interest and concern and to gather factual information relative to the subject matter of the regulation. Alternatively, the department may elect to request that persons who have responded to the notice make written submittals of comments, concerns and suggestions relative to the proposed regulation.
- 2. Preparation of working draft. Subsequent to the initial public input on the development of any regulation, the department shall develop a working draft of the proposed regulation. In certain instances where the technical nature of the subject matter merits, the department may request that industry or professional groups develop a working draft. A copy of this draft will be furnished to all persons who responded to the notice indicating an interest in the regulation and to those persons participating in the initial comment phase of the development process. Persons to whom a copy of the working draft is furnished will be invited to submit written comments on the draft.

# B. Submission of regulation under the Administrative Process Act (APA).

Upon conclusion of the development process, the department shall prepare the regulation for submission to the Registrar of Regulations under the provisions of the Administrative Process Act ("APA"). The department shall furnish to all persons identified as having a potential interest in the subject matter, a copy of the regulation as submitted to the Registrar of Regulations together with a copy of the general public notice of opportunity for oral or written submittals as to that regulation. A cover letter accompanying these documents shall explain the deadlines for submitting formal public comments under the APA. In some cases, the public opportunity to comment may be limited to written submittals. This election shall be clearly set forth in the notice. The date and place to which submittals must be made shall be clearly specified. Where a public hearing is to be held, the time, date, and place shall be clearly specified. Additionally, the date by which persons intending to participate in the public hearing should notify the department of their interest shall be noted. Persons who will participate will be encouraged to submit written copies of their comments in advance or at the public hearing in order to insure that all comments are accurately reflected in the formal transcript of the hearing.

C. Adoption period.

Upon issuing an order adopting a regulation, the department, at its discretion, may send to participants a copy of the regulation as adopted, together with its response to comments made during the public hearing or written submittal period.

## D. Publication of final regulation.

When any regulation is published, the department shall print and distribute such regulation. The distribution of any regulation shall be made with a goal of increasing voluntary compliance.

# VIRGINIA DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES

<u>Title of Regulation:</u> VR 115-04-14. Rules and Regulations for Enforcement of the Virginia Pest Law - Cotton Bollweevil Quarantine.

Statutory Authority: §§ 3.1-188.23 and 3.1-188.24 of the Code of Virginia.

Effective Date: May 15, 1986

#### Summary:

The purpose of the amendments to this regulation is to require (i) farmers to declare their cotton acreage to be grown each year; and (ii) a payment of \$10.00 per acre of cotton grown to defray the cost of the monitoring and eradication program (same as Northern North Carolina cotton growers).

VR 115-04-14. Rules and Regulations for Enforcement of the Virginia Pest Law - Cotton Bollweevil Quarantine.

## Regulation 2. § 1. Definitions.

The following words and terms, when used in these regulations, shall have the following meaning, unless the context clearly indicates otherwise:

"ASCS" means United States Department of Agriculture, Agricultural Stabilization and Conservation Service.

"Bollweevil" means the live insect , ("Anthonomus grandis" Boheman ) , in any living stage of development.

"Board" means the Board of the Virginia Department of Agriculture and Consumer Services.

"Certificate" means a document issued or authorized by an inspector to be issued under these regulations by an inspector to allow the movement of regulated articles to any destination.

"Compliance agreement" means a written agreement between a person engaged in growing; dealing in; or moving grower, dealer, or mover of regulated articles; and the Virginia Department of Agriculture and Consumer Services, wherein in which the former agrees to comply with conditions specified in the agreement by the inspector who executes the agreement on behalf of the department, to prevent the dissemination spread of the bollweevil.

"Commissioner" means the Commissioner of the Virginia

Department of Agriculture and Consumer Services or his designee.

"Cotton" means parts and products of plants of the genus "Gossypium", before processing.

"Cottonseed" means cottonseed from which the lint has been removed.

"Gin trash" means all of the material produced during the cleaning and ginning of seed cotton, bollies, or snapped cotton, except for the lint, cottonseed, and gin waste.

"Grower" means a farm operator or producer, whether he owns the owner of the land or not.

"Infestation" means the presence of the bollweevil, or the existence of circumstances that make it reasonable to believe that bollweevil is present.

"Inspector" means any employee of the Virginia Department of Agriculture and Consumer Services, or other person authorized by the commissioner to enforce the provisions of the quarantine and regulations.

"Limited Permit" means a document issued or authorized to be issued by an inspector to allow the movement of noncertifiable regulated articles to a specified destination for limited handling, utilization use, process, or for treatment.

"Lint" means all forms of raw ginned cotton, either baled or unbaled, except linters and waste.

"Moved (Movement, Move)" means shipped; offered for shipment to a common carrier; received for transportation or transported by a common carrier; or carried, transported, moved, or allowed to be moved by any means. "Movement" and "Move" shall be construed accordingly.

"Person" means any individual, corporation, company, society, or association or other organized group of any of the foregoing.

"Regulated area" means the entire State Commonwealth of Virginia.

"Seed cotton" means cotton as it comes from the field prior to ginning.

"Used cotton harvesting equipment" means equipment previously used to harvest, strip, transport or destroy

cotton.

## Regulation 1 § 2. Notice of quarantine.

Under the authority of Title §§ 3.1-188.20 through 3.1-188.31:2 of the Code of Virginia, a quarantine of the State Commonwealth of Virginia and all cotton producing states and countries infested with the boliweevil is hereby established to control, eradicate, and prevent the dissemination spread of the cotton bollweevil, "Anthonomus grandis" Boheman.

#### Regulation 3 § 3. Regulated articles.

- A. The following shall not be moved from outside Virginia into this state Commonwealth, or between points within Virginia, or interstate, in any manner or method, except in accordance compliance with the conditions prescribed in these regulations:
  - (A) I. The bollweevil , ("Anthonomous grandis" Boheman ) , in any living state of development.
  - (B) 2. Seed cotton.
  - (C) 3. Gin trash.
  - (D) 4. Used cotton harvesting equipment.
  - (E) 5. Any other products, articles, or means of conveyance of any character whatsoever, kind not covered by subparagraphs (1) through (4) [ subsection A; 1-4 subdivisions 1 through 4] above [ of this paragraph regulation], when it is determined by an inspector that they present a hazard of spread of the bollweevil and the person in possession thereof has been so is notified.

## Regulation 4 § 4. Requirements for program participation.

- A. All cotton farm operators in Virginia are hereby required to participate in the eradication program. Participation shall include timely reporting of acreage and field locations, compliance with regulations, and payment of fees. Farm operators within the Commonwealth shall be notified through either the extension offices, VDACS, ASCS, or newspapers of their program costs on a per acre basis on or before March 15 of each year. The following procedures are required for participation in the program:
  - 1. Completing a Cotton Acreage Reporting Form at the ASCS office by April 15 of the current growing season for which participation is desired. At this time a nonrefundable fee of \$5.00 per acre, based on that acreage reported by the farm operator, shall be paid. All acreage reported after April 15 will be subject to an additional assessment of \$5.00 per acre in addition to the program cost.
  - 2. On or before the July 1, the remaining share of the farm operators payment of \$5.00 for those acreages

- shall be paid. Final adjustment will be based on ASCS measured acreage of reported fields. If measured acreage is not available by July 1 the remaining share shall be based on the ASCS certified acreage. Any final adjustment based on measured acreage shall be made upon notification of actual measured acreage by ASCS or program personnel.
- 3. All fees shall be paid by the farm operator. Fees shall be made payable to Treasurer of Virginia and collected by ASCS.
- 4. Noncommercial cotton shall not be planted in Virginia unless the grower applies for and receives an exemption to grown cotton. Applications, in writing, shall be made to the State Entomologist stating the conditions under which the grower requests such exemption. [ The decision of whether or not to exempt all or part of these requirements shall be exempted shall be ] based on the following:
  - a. Location of growing area,
  - b. Size of growing area,
  - c. Pest conditions in the growing area,
  - d. Accessibility of growing area,
  - e. Any stipulations set forth in a compliance agreement between the individual and the Department of Agriculture and Consumer Services that are necessary for the effectuation of the program.
- B. Farm operators whose ASCS measured acreage exceeds the grower reported acreage by more than 10%, shall be assessed an additional \$5.00 per acre on that acreage in excess of the reported acreage. Any person whose reported acreage exceeds the ASCS measured acreage by more than 10% due to emergency or hardship conditions may apply for a waiver of the additional assessment. Any farm operator applying for a waiver of the additional assessment shall make application in writing to the State Entomologist stating the conditions under which the waiver is requested.
- C. Failure to pay all remaining fees on or before July 1 of the current growing season will result in an additional assessment of \$10 per acre. Failure by a farm operator to pay all program costs as of August 1 or upon notification of ASCS measured acreage, whichever is later, shall be a violation of The Virginia Cotton Bollweevil Quarantine. The farm operator when found in violation and upon notification shall completely destroy all cotton not found to be in compliance with the provisions of this section. If such farm operator fails to comply with these regulations, the Commissioner of Agriculture and Consumer Services, through his duly authorized agents, shall proceed to destroy such cotton, and shall compute the actual costs of labor and materials used, and the farm operator shall pay

to the commissioner such assessed costs. No damage shall be awarded the grower of such cotton for entering thereon and destroying any cotton when done by the order of the commissioner.

- D. The decision of whether to waive all or part of these additional assessments or payment dates shall be made by the State Entomologist and notification given to the farm operator within two weeks after receipt of such application. The decision shall be based on the following: (i) meteorological conditions, (ii) economic conditions, and (iii) any other uncontrollable destructive forces.
- E. Acreage subject to emergency or hardship conditions after all the growers' share of the program have been paid and prior to the initiation of field operations may be considered for a refund. The refund amount will be determined by the actual program cost per acre up to the time of emergency or hardship.
- F. The commissioner may purchase growing cotton when he deems it in the best interest of the program. Purchase price shall be based on the ASCS farm established yield for the current year.
- $\S$  5. Conditions governing the issuance of certificates and permits to allow the movement of regulated articles. Regulation 4.
- A. Certificates shall be issued by the inspector for movement of the regulated articles designated in Regulation  $\S$  3 under any one of the following conditions when:
  - 1. In the judgment of the inspector, they have not been exposed to infestation.
  - 2. They have been examined by the inspector and found to be free of infestation.
  - 3. They have been treated, under the observation of the inspector, in accordance compliance with methods selected by him to be effective under the conditions in which applied.
  - 4. Grown, produced, stored, or handled in such manner that, in the judgment of the inspector, no infestation would be transmitted. thereby:
- B. Limited permit. Limited permits may be issued by the inspector for the movement of noncertified regulated articles specified under Regulation  $\S$  3 to specified destinations for limited handling, utilization use, processing, or treatment, when he determines that no hazard of spread of the bollweevil exists.
- C. Special permits. Special permits may be issued by the State Entemologist Virginia Department of Agriculture and Consumer Services to allow the movement of bollweevil in any living stage and any other regulated articles for scientific purposes, under such conditions as may be

prescribed in each specific case.

D. Compliance agreement. Compliance agreements may be issued by the inspector. As a condition of issuance of receiving a certificates certificate or limited permits permit for the movement of regulated articles, any person engaged in purchasing, assembling, exchanging, handling, processing, utilizing, treating, or moving such article may be required to sign a compliance agreement. stipulating The agreement shall stipulate that he will maintain such the required safeguards against the establishment and spread of infestation will be maintained and will comply with such the conditions as to governing the maintenance of identity, handling, and subsequent movement of such articles, and the cleaning and treatment of means of conveyance and containers used in the transportation of such articles, as may be required by the inspector .

Regulation 5. § 6. Cancellation of certificates and permits.

Any certificate or permit which has been issued or authorized may be withdrawn by the inspector if he determines determined that the holder thereof has not complied with any condition for the use of such the documents.

Regulation 6. § 7. Compliance agreements; and cancellation thereof.

- A. Any person engaged in the business of growing, handling, or moving regulated articles may enter into a compliance agreement to facilitate the movement of such articles under this quarantine. Compliance agreement forms may be obtained from an inspector.
- B. Any compliance agreement may be cancelled by the inspector who is supervising its enforcement whenever he finds that the other party thereto covered by the agreement has failed to comply with the conditions of the agreement as stated. Cancellation appeals may be taken to the commissioner in writing within seven calendar days of the cancellation.

Regulation 7.  $\S$  8. Assembly and inspection of regulated articles.

Persons (other than those authorized to use certificates, limited permits, or reproductions thereof) who desire to move regulated articles which must be accompanied by a certificate or permit shall, as far in advance as possible, request an inspector to examine the articles prior to movement. Such The articles shall be assembled at such points a place and in such a manner as the inspector designated by the inspector to facilitate inspection.

Regulation 8-  $\S$  9. Attachment and disposition of certificates or permits.

A. If a certificate or permit is required for the movement of regulated articles, the certificate or permit

shall be securely attached to the outside of the container in which such the articles are moved. except that, where However, if the certificate or permit is attached to the way-bill or other shipping document, and the regulated articles are adequately described on the certificate, permit, or shipping document, the attachment of then the certificate or permit need not be attached to each container of the articles is not required.

B. In all cases, certificates, or permits shall be furnished given by the carrier to the consignee at the destination of the shipment.

Regulation 9. § 10. Inspection of shipments.

Any product or article moved by any means or manner intrastate or offered to a common carrier for shipment intrastate, or destined for interstate movement, which contains or which the inspector has probable cause to believe contains either infestations, infested products or articles, the movement of which is controlled by these regulations, shall be subject to inspection by an inspector and stopped if necessary at any time or place, and when actually found to involve danger of dissemination of the bollweevil to noninfested localities, measures to eliminate infestation may be required by the inspector.

Any product to be moved either within or out of the Commonwealth, which is suspected of containing the bollweevil, shall be subject to inspection. The shipment may be stopped at any time or place by an inspector. When such a product is found to threaten the spread of the bollweevil to noninfested areas, the inspector may require measures to eliminate the infestation.

Regulation 10. § 11. Rules.

All cotton farm operators in a regulated area shall submit a Cotton Acreage Reporting Form by the 15th of June each growing season to the County ASCS office until notified by the Commissioner in writing, however, no further cost of the trail bollweevil eradication program shall be shared by the grower after the 1989 growing season.

The commissioner, pursuant to § 3.1-188.30 of the Code of Virginia, may determine costs for services, products, or articles that shall be paid by the persons affected when those services, products, or articles are beyond the reasonable scope of the law.

## Regulation 11. Violations

Persons convicted of violating any of these regulations shall be punished in accordance with Section 3.1-188.29 of the Virginia Pest Law.

<u>Title of Regulation:</u> VR 355-01-3. Virginia Voluntary Formulary.

Statutory Authority: §§ 32.1-12 and 32.1-81 of Title 32.1 of the Code of Virginia.

Effective Date: May 15, 1986

#### Summary:

The revised Virginia Voluntary Formulary amends the Formulary that was effective August 1, 1985. The revised Voluntary Formulary lists drugs of accepted therapeutic value commonly prescribed within the Commonwealth which are available from more than one source of supply. It also lists distributors of drug products and their respective manufacturers which the board has found acceptable based upon data submitted by these distributors and their respective manufacturers.

The Virginia Voluntary Formulary is needed to enable citizens of Virginia to obtain safe and effective drug products as a reasonable price consistent with high quality standards. Without the Formulary, physicians, dentists, and pharmacists in Virginia would not have the assurance that those generic drug products that may be substituted for brand name products have been evaluated and judged to be interchangeable with the brand name products.

## **EMERGENCY REGULATION**

## **BOARD OF EDUCATION**

<u>Title of Regulation:</u> VR 270-01-0006. Regulations Governing Pupil Transportation Including Minimum Standards for School Buses in Virginia.

Effective Date: April 1, 1986 through March 31, 1987

#### Summary:

Physical Requirements for School Bus Drivers. — The Department of Education, many local school divisions or physicians representing them, the Medical Society of Virginia, and the National Transportation Safety Board have determined that there is an urgent need for objective minimum physical requirements for school bus drivers. This regulation is being promulgated as an emergency regulation to give sufficient notice to local school divisions for implementing the new regulation for the 1986-87 school year. School divisions normally establish contracts or finalize policy for the physical examination of drivers in the late spring; therefore, this emergency regulation will become effective April 1, 1986. It will remain in effect for a maximum of twelve months unless superseded by a permanent regulation.

Concurrent with this request, the department is preparing the transmittal of "Proposed Action on Regulation" and other required documents for adoption of a permanent regulation through the Virginia Registrar of Regulations.

# PART IV. REQUIREMENTS FOR SCHOOL BUS DRIVERS.

- $\pm$  § 4.1. No school board shall hire, employ, or enter into any agreement with any person for the purpose of operating a school bus transporting pupils unless the person shall:
- A. Have a physical examination of a scope prescribed by the Board of Education with the advice of the Medical Society of Virginia and furnish a form prescribed by the Board of Education showing the results of such examination.
  - 1. No person shall drive a school bus unless he is physically qualified to do so and has submitted a School Bus Driver's Application For Physician's Certificate signed by the applicant and the doctor for the applicable employment period.
  - 2. A person is physically qualified to drive a school bus if he:
    - a. Has no loss of a foot, a leg, a hand, or an arm

which interfers with the ability to control and safely drive a school bus;

- b. Has no impairment of the use of a foot, a leg, a hand, fingers, or an arm, and no other structural defect of limitation likely to interfer with his ability to control and safely drive a school bus;
- c. Has no known medical history or clinical diagnosis of diabetes mellitus currently requiring insulin for control likely to interfere with his ability to control and safely drive a school bus;
- d. Has no current clinical diagnosis of myocardial infarction, angina pectoris, coronary insufficiency, thrombosis, or any other cardiovascular disease of a variety known to be accompanied by syncope, dyspnea, collapse, or congestive cardiac failure;
- e. Has no known medical history or clinical diagnosis of a respiratory dysfunction likely to interfere with his ability to control and drive a school bus safely;
- f. Has no known current clinical diagnosis of highblood pressure likely to interfer with his ability to operate a school bus safely;
- g. Has no known medical history or clinical diagnosis of rheumatic, arthritic, orthopedic, muscular, neuromuscular, or vascular disease which would interfere with his ability to control and operate a school bus safely;
- h. Has no known medical history or clinical diagnosis of epilepsy or any other condition which is likely to cause loss of consciousness or any loss of ability to control a school bus;
- i. Has no known mental, nervous, organic, or functional disease or psychiatric disorder likely to interfere with his ability to drive a school bus safely;
- j. Has both distant and near visual acuity of at least 20/40 (Snellen) in each eye with or without corrective lenses, and field of vision of at least 70° in the horizontal meridian in each eye, and the ability to recognize the colors of traffic signals and devices showing standard red, green, and amber;
- k. First perceives a forced-whispered voice in the better ear at not less than five feet with or without the use of a hearing aid or, if tested by use of an audiometric device, does not have an average hearing loss in the better ear greater than 40 decibels at 500 Hz, 1,000 Hz, and 2,000 Hz with or without a hearing aid when the audiometric device is calibrated to American National Standard (formerly ASA Standard) Z24.5-1951;

I. Does not use an amphetamine, narcotic, or any habit-forming drug without appropriate physician supervision.

The immunization of female cattle, while calves, enhances their value; requiring such immunization before a cow enters the state reduces the risk to all Virginia cattle of contracting brucellosis.

# **Estimated Impact:**

- a) Number and types of regulated entities or persons affected—While it would be virtually impossible to enumerate the livestock markets, registered cattle associations, cattle dealers, and livestock sales managers in other states affected (and the impact of the proposed regulations would be on entities outside Virginia), the impact should be minimal, since already 24 states require such vaccination for cattle entering their borders. An estimated 12,000 cattle pass through Virginia each year that would be subject to this proposed regulations, but already approximately 75% have been vaccinated for brucellosis in a manner consistent with the proposed regulation. This regulation would deal with the remaining 25%.
- b) Projected cost to regulated entities (and to the public, is applicable for implementation and compliance—see Item "a", above.
- c) Projected cost to agency for implementation and enforcement-None.
- d) Source of funds Since there are no known costs to the agency, there is no need for additional funds for the implementation of these proposed regulations.

Part II - Transportation of horses.

Transportation of horses regulates transportation of loads of more than six horses being transported to a commercial slaughter facility. Standards are set forth for vehicles, loading and unloading, cleaning and disinfection, protection during transport, food, water and exercise, grouping of horse, and handling of injured or physically disabled horses.

<u>Issues:</u> Issues to be considered include: 1. The need for such regulations. 2. What standards are necessary to accomplish the purpose of these regulations. 3. The economic impact of these regulations on regulated entities and the public.

<u>Basis:</u> Numerous instances of inhumane treatment of animals during transport and the inability to deal with these using existing enforcement measures requires the promulgation of these regulations.

Purpose: The purpose of these regulations is to specify

those requirements to be met when transporting live companion animals and horses that will preclude the inhumane treatment of these animals and foster handling and care practices that will enhance their well-being during periods of transit within the state.

#### STATEMENT

Statement of Purpose and Impact: This regulation is to ensure that all lawn and turf seeds are truthfully labeled within testing tolerance of the labeler's guarantee for the presence of noxious weed seeds. It will establish a fair and equitable marketing system whereby both the labeler and consumer can identify quality seed from the information that appears on the label. To ensure the smallest amount of disruption in the same marketing area, the regulation conforms in every respect to those adopted in Pennsylvania and proposed for adoption in Maryland, Delaware and New Jersey.

Impact: This regulation affects all persons who market lawn and turf seed in Virginia to include approximately 120 seed producers, processors or labelers, and 32 registrants of lawn and turf products. Purchasers of lawn and turf seed affected include a major portion of the 1.1 million home owners, 30 sod producers, 240 golf courses, approximately, 800 public schools, 80 colleges, approximately 100 federal, state and municipal parks or recreation areas, other state agencies, airports, apartment complexes, business establishments and all areas maintained in turf for aesthestic value. This regulation was specifically and meticulously designed to disrupt to the

smallest extent possible that lawn and turf seed already on the market. All seed presently marketed can continue to be marketed, but the label will reveal by name and rate of occurrence the noxious weed seed which are present in lawn and turf seed.

Statement of Basis: To ensure that seed identified as lawn and turf seed be labeled with the name and number per ounce or per pound of restricted noxious weed seeds under the heading of Noxious Weed Seed or Undesirable Grass Seed, if any are present. Provide the labeler of lawn and turf seed an opportunity to label and market uncontaminated seed in fair competition with all other on the market. Provide information to the purchaser that is not available from any other source.

For the above reasons, it is necessary to establish a noxious weed seed list specifically for lawn and turf seed that is different from agricultural seed. In addition, it is necessary to maintain an inspecting, sampling, and testing program that will monitor lawn and turf seed sold in order that the purchaser will be protected.

# **STATEMENT**

Basis: Section 32.1-120 of the Code of Virginia authorizes the Virginia Statewide Health Coordinating Council to revise as necessary the State Health Plan, which contains both nonregulatory and regulatory material. Related laws include § 32.1-102.1, et seq. of the Code of Virginia and the National Health Planning and Resources Development Act of 1974 (P.L. 93-641), as amended.

<u>Purpose:</u> The purpose of these proposed regulations is to contain the cost of health care in Virginia by promoting an efficient distribution of efficacious computed tomography and magnetic resonance imaging services, consistent with the population's need for reasonable access to such services.

These regulations are expected to reduce the cost of complying with the Medical Care Facilities Certificate of Public Need law by setting forth specific standards and

criteria for the evaluation of applications. The regulations are intended to avoid the high cost of preparing and analyzing superfluous and subjective information that would otherwise be submitted to defend a project, and to avoid the preparation and analysis of applications for projects that would not normally be approved.

Summary: Computed tomography (CT) and magnetic resonance imaging (MRI) services are highly sophisticated technologies by which cross-sectional images of the human anatomy may be constructed with the assistance of computer analysis. Under state law, a medical care facility may not acquire or place in service a CT or MRI device without having obtained a Certificate of Public Need. A major reference document pertaining to the evaluation of Certificate of Public Need applications is the State Health Plan, as amended, which presently contains standards specific to CT and MRI services. Considerable experience with these technologies has been gained, however, since the promulgation of those standards.

The proposed new standards are the result of a review of recently published information on CT and MRI services as well as information provided by an ad hoc advisory panel of interested parties consistent with the council's Guidelines for Public Participation in the Development of Regulations. This information led to a number of proposed changes that would focus the regulations primarily upon efficient use of resource capacity, logical distribution of resources, and efficacy of operations.

Proposed deletions from the present CT standards are requirements that all applicants must be hospitals that (alone or in combination with other health service providers) offer 24-hour ER services with physician on duty, offer a radiology department that has at least three full time radiologists and performs at least 30,000 examinations annually, and have active nuclear medicine and ultrasound facilities that are effectively utilized.

Two other current CT standards are proposed to be deleted. These require the proposed owner to provide written assurances that CT services will be available for emergency cases at all times, and that no patient referred for an indicated study will be denied timely access to the service. The proposed standards would require supervision of a CT service by one or more qualified physicians rather than by radiologists.

The current CT standards require a projected annual utilization of 2,500 HECTs (Head Equipment Computed Tomograms) as a condition of approval, but do not specify how that projection is to be derived. The proposed standards would set forth a specific formula for projecting HECTs and would raise the required number to 3,000.

Since the present CT standards were developed prior to the introduction of MRI services, they fail to address the impact of one upon the other. The American Hospital Association estimates that at least 34% of current CT service volume will be replaced by MRI. Accordingly, the proposed regulations preclude the addition of a stationary CT scanner to an existing CT service if the facility also offers MRI services (or is approved to do so), but whose MRI services have not been in operation for at least one year.

Three elements of the current MRI standards are proposed to be deleted. First, the site would no longer need to be a hospital; however, the service would have to be under the operational control of one or more hospitals that meet standards similar to those currently required. Second, there would no longer be a restriction of actions by parties to a previous shared service agreement. Third, there would no longer be a reduced standard for placement for an MRI device at a hospital with an AMA-accredited residency training program in diagnostic radiology that proposes to perform a significant amount of MRI work within a formal investigational program.

Impact: These regulations would apply to any medical care facility desiring to establish or expand CT or MRI services. While general hospitals are the most likely such facilities (they numbered 108 as of January, 1986), a small number of private physicians' offices could also be affected. These regulations will expand opportunities for small businesses interested in providing CT and MRI services compared with such opportunities under the current regulations, primarily through recognition of mobile technology.

### **STATEMENT**

<u>Basis</u> <u>and Authority:</u> Chapter 7, Title 28.1 authorizes the State Health Commissioner to limit or set boundaries on taking shellfish, finfish, or crustacea where pollution conditions render the produce unfit for market, and may

establish standards by which fish, shellfish, and crabmeat are sanitary and fit to market. The State Board of Health, § 32.1-248 of Title 31.1, is authorized to adopt regulations closing any river in which a toxic substance is present in such a manner as to constitute a present threat to public health and to amend said regulations without application of the Administrative Process Act where the threat has been abated in part.

<u>Purpose</u>: The State Board of Health and State Health Commissioner promulgate these amended regulations to restrict taking, distribution, and consumption of finfish from designated portions of the James River and its tributaries because of contaminant levels in finfish above the action level for kepone. Levels of kepone, a toxic pesticide, have been found to constitute a threat to public health in specified finfish species.

Summary and Analysis: The proposed amendment slightly revises the regulations which became effective on July 1, 1982. By this amendment 2, recreational finfishing and crabbing continues without restriction in all portions of the James River and its tributaries. As in the previous regulations, commercial fishing for Striped Bass, Croaker, and Eel not depurated is prohibited throughout the effective period of this amendment. All previous restrictions on commercial crabbing, removed from the regulations, continue to be suspended in this amendment 2. As in the previous amendment, Spot are not restricted for commercial finfishing between July 1, and December 31.

Changes reflected in this amendment deal with simplifying and clarifying language, as required by the Registrar of Regulations for all regulations promulgated in Virginia.

Unless specifically restricted, all other finfish may be taken commercially and marketed.

<u>Impact:</u> The amendment continues the kepone ban on the James River as it has existed for the past two years under amendment 1.

Limitations on Striped Bass and Croaker constitute a continuing economic impact to the industry. An estimated 200 working watermen are affected by the fishing limitations of this amended ban.

Monitoring costs to the Commonwealth will be approximately \$300,000 during the effective period. There is no adverse impact to local government anticipated from this amendment.

Forms: None required

<u>Evaluation</u>: Quarterly review of monitoring data is required to be submitted to the Commissioner, and to the Board of Health, to assure closure for the minimum resource. Enforcement is vested with the Virginia Marine Resources Commission.
