Independent company usage in excess of 1,000 minutes per line will be billed to the subscriber at the rates specified in A3.2.12.B.2. Call detail information will be provided on the customer bill for billed usage in excess of the 1,000 minute allowance. A3.8 Joint User Service

Joint User Service is available for new installations, and for relocations, transfers of service or additions of lines or trunks, not to exceed a total of five joint users.

Existing customers with five or less joint users sharing in the use of their service may add lines or trunks and may continue their present service arrangement located at the same address under the terms and conditions described below.

A3.8.1 Application and Terms and Conditions

A. In general, business exchange service is furnished for the exclusive use of the business subscriber and his employees, agents, and representatives. Joint User Service is a shared service arrangement which allows the business telephone exchange service of a subscriber to be used, when designated by the primary subscriber, by individuals, firms, or corporations not otherwise permitted use of the subscriber's business service by this guidebook.

Existing primary business subscribers with more than five joint users sharing in the use of their service must discontinue subscription to Joint User Service by November 6, 1997. If appropriate, they may be converted to Shared Tenant Service.

- **B.** Joint User Service is permitted in connection with the following:
 - 1. Business individual line flat rate, or measured rate.
 - 2. Commercial PBX flat rate or message rate service.
 - 3. Hotel PBX Service.
 - 4. Centrex Type Services (excluding Dormitory Centrex Type Services).
- C. Application for Joint User Service and for changes in service or equipment furnished herewith, must be executed by the primary subscriber. The primary subscriber is responsible for payment of all charges incurred, regardless of whether such charges are associated with his usage or that of his joint users. Stations, additional listings and miscellaneous equipment are furnished, with the consent of the primary subscriber, for use of the joint user, at regular rates.
- **D.** Charges for joint user service date from the day the Company's information records are posted and are payable monthly in advance. The minimum chargeable period for joint user service is the life of the directory issue in which the listing first appears, not to exceed one year from the effective date of the listing. Contracts for joint user service are self-renewing for periods of one directory issue, not to exceed one year from the effective date of the directory. In the event the joint user listing does not appear in the directory, the minimum chargeable period is for one month.
- E. Joint user service is terminated and charges for joint user service are automatically discontinued upon termination of the primary subscriber's telephone service. Charges for joint user service may be discontinued at the request of the subscriber provided that the joint user no longer utilizes any of the customer's service or equipment, and also that the terms of the minimum service period have been satisfied.
- **F.** The total charges for telephone service allocated by the primary subscriber among the subscriber and his joint users shall not exceed the charges of the Company to the primary subscriber as set forth in this Guidebook.
- G. Joint users of a primary subscriber's service must have the option of obtaining service directly from the Company.
- **H.** A joint user is entitled to one listing in the alphabetical section of the telephone directory. (M1)
- Joint user service is not provided in connection with public telephone service, or foreign exchange service.

Directory Assistance calls will not be charged to the approved telephone number. The DA exemption applies to local listings only. The exemption does not apply to other types of directory service requests, such as requests for numbers outside of the Company's local calling and LATA/NPA serving areas for the approved telephone number. To obtain an exemption, the customer must complete the appropriate form and have it certified by a registered physician or certifying agent. Local Directory Assistance exemption is valid for a two-year period and must be renewed. Failure to provide the required documentation may result in loss of the exemption. Directory Assistance usage will be monitored by the Company and is subject to review and investigation. Misuse of the exemption by a customer could result in its removal. Directory Assistance exemption is a voluntary program of the Company that may be terminated at any time.
 - 3. The Directory Assistance disabled exemption may be obtained from the Company for a reseller's disabled end user upon proper certification. The reseller is responsible for informing their disabled end users of the Directory Assistance exemption. The reseller is obligated to obtain from their end users the appropriate certification forms confirming end user disability. Reseller lines will not receive the Directory Assistance disabled exemption absent this certification provided to the Company by the reseller.
- **C.** An Operator Dialed Surcharge, as described in A3.14.C.2, will be applicable to all calls to Directory Assistance service handled by the "0" operator, provided that the "0" operator is not the only means of reaching Directory Assistance.

 - 15. Recurring rate associated with Local Optional Service or Shreveport Metropolitan Calling Plan.

A3.18.2 Charitable Institutions

A concession of 25 percent from the regular business rate is allowed to corporations, associations and institutions, or any branch thereof who comply with all of the following qualifications:

- A. Are dependent upon voluntary contributions for their support.
- **B.** Are exclusively engaged in charitable work.

If LUD is initiated at the same time an order is being issued for any other purpose, the charge preceding does not apply. When an order is issued solely to initiate LUD, no service charges apply for BellSouth Business Plus service only.

For flat, measured, and message rate customers, LUD will automatically be provided for calls to the Expanded Local Calling Area and no service ordering charge or per message charge will apply.

Such calls are itemized on the subscriber's billing statement and are billed outside any applicable calling allowance or usage billing reductions for dialed sent-paid local calls.
- G. When individual lines or trunks are provided in addition to LightGate service, MegaLink channel service, FlexServ service or MegaLink ISDN¹ service, they are provided at the rates stated in A3.26.2.C. following. A3.31.1 Description of Service

- A. Effective December 8, 2017, new Lifeline service is available only to qualifying residence subscribers who reside in Connect America Fund II (CAF II) Funded Census Blocks, shown in Exhibit B of the Petition of AT&T Louisiana for Order Confirming Relinquishment of Eligible Telecommunications Carrier Designation in Specified Areas, Order No. S-34632, effective November 3, 2017. Effective March 16, 2018, Lifeline service will be available only to qualifying subscribers who reside in the CAF II Funded Census Blocks.
- **B.** The Lifeline program is designed to increase the availability of telecommunications services to low income subscribers by providing a credit to monthly recurring local service charges for qualifying residential subscribers. Basic terms and conditions are in compliance with FCC rules and regulations including the FCC Report and Order and Further Notice of Proposed Rulemaking in WC Docket No. 11-42, adopted January 31, 2012, and the Lifeline and Link Up Reform and Modernization Third Report and Order, Further Report and Order, and Order on Reconsideration, WC Docket No. 11-42 (rel. April 27, 2016) ("Lifeline Reform and Modernization Order"), including implementation of a National Lifeline Eligibility Verifier.
- **C.** Lifeline is supported by the federal universal service support mechanism.
- **D.** Federal uniform support of *\$5.25* is available for each Lifeline service and is passed through to an eligible customer via a monthly Lifeline credit. The amount of credit will not exceed the charge for local service.

A3.31.2 Terms and Conditions

A. General

- 1. One low income credit is available per household and is applicable to the primary residential connection only. Lifeline support is limited to a single subscription per household where household is defined to be any individual or group of individuals who are living together at the same address as one economic unit. For the purposes of this rule, an economic unit consists of all adult individuals contributing to and sharing in the income and expenses of a household.
- 2. A Lifeline customer may subscribe to any local service offering available to other residence customers.
- 3. Toll blocking, if elected, will be provided at no charge to the Lifeline subscriber.
- 4. The deposit requirement is not applicable to a Lifeline customer who subscribes to toll blocking. If a Lifeline customer removes toll blocking prior to establishing an acceptable credit history, a deposit may be required. When applicable, advance payments will not exceed the connection and local service charges for one month.
- 5. Lifeline service is exempt from the Installment Billing Service Fee.
- 6. The Federal Universal Service Charge will not be billed to Lifeline customers.
- 7. A Lifeline subscriber's local service will not be disconnected for non-payment of toll charges. Local service may be denied for non-payment of local charges in accordance with A2. Access to toll service may be denied for non-payment of toll charges. A Lifeline subscriber's request for reconnection of local service will not be denied if the service was previously denied for non-payment of toll charges.
- 8. Lifeline is not available for resale.

- **B.** Each serving wire center has a unique set of vertical and horizontal (V&H) coordinates. These coordinates are used for calculating the airline mileage between the wire centers as specified in A3.36.3.
- C. As exceptions to the airline mileage calculated as specified in A3.36.3, calls between the following wire centers are always rated as 17-22 mile calls. This rating allows the local usage caps specified for Local Optional Service (A3.2.9) or Local Optional Service Option B (A3.2.10) to apply to these calls as they did before V&H coordinates were changed in September, 1992 and June, 2007.

A. AT&T Business Local Calling Assurance is offered where facilities and equipment are available.

Eligible customers are existing business customers who have received a competitive offer and are considering switching their Business Local Exchange Access Line service to another carrier (proof of competitive offer may be required), as well as business customers who have their local exchange access line service with another competitive local exchange carrier within the AT&T service area, and who now wish to establish their business local exchange access line service with the Company. This eligibility requirement is not applicable to customers with existing AT&T Business Local Calling Assurance service prior to September 1, 2016.

- **B.** AT&T Business Local Calling Assurance is a one (1) to four (4) line offering available to business subscribers and consists of the following for a fixed monthly rate:
 - Business Access Line (flat rate-unlimited local calling)
 - Caller ID Deluxe
 - Remote Access to Call Forwarding (or) Call Forwarding Variable
- **C.** All of the terms, conditions and limitations specified elsewhere in this section or in Section A13. apply to the respective services and features provided as part of this service.
- **D.** AT&T Business Local Calling Assurance requires a 12-month² or 24-month term agreement¹. The fixed monthly rate provided with this service continues after the end of the term. Customers may also subscribe to Business Local Calling Assurance on a Month-to-Month basis at prices as shown in paragraph A3.46.2.
- E. Normally applicable service charges (i.e. line connection charges) will not apply for lines included in this offering.
- F. This offering is only available to single location subscribers and only one package is permitted per location.

A3.47.1 Description

AT&T Business Local Calling (BLC) is an optional business package that provides multiple line option packages which include varying combinations of a network access line, unlimited local usage, select calling features and hunting/grouping service (optional). Additional calling feature options are also available.

A3.47.2 Terms and Conditions

- **A.** AT&T Business Local Calling is available to business customers who agree to a 12-Month, 24-Month¹ or 36-Month¹ term and who commit to the line option packages and prices as shown in A3.47.6 following. Customers may also subscribe to AT&T Business Local Calling on a Month-to-Month basis at prices as shown in A3.47.6 following.
- **B.** AT&T Business Local Calling is not available on Foreign Exchange Service, WATS access lines, PBX Trunks, Centrex, ISDN, PRI, 800/900 Service, Hot Line or Coin Services.
- C. AT&T Business Local Calling is only available where facilities and equipment permit.
- **D.** All lines in an AT&T Business Local Calling account must be subscribed to a line option package as listed in A3.47.6 following. Multiple options per account are permissible.
- E. Lines subscribed to AT&T Business Local Calling cannot be subscribed to any other optional local calling plan.

Service charges associated with changing to/from hunting service, if applicable, will also be waived for AT&T Business Local Calling customers. Standard NRCs will apply to standalone features added to an existing AT&T Business Local Calling account when such features are added subsequent to the initial subscription. This waiver of NRCs is not applicable for customers subscribing to a Month-to-Month plan or when moving or transferring their telephone service as described in A3.47.2.Q following.
