Hate Crime in New York State 2018 Annual Report

Hate crime incidents reported to police departments and sheriffs' offices in New York State decreased 6.3 percent in 2018, despite a 9 percent increase in reported hate crime incidents in New York City. There were 352 hate crimes reported in the five boroughs, compared to 323 in 2017. The increase in reports to police occurred in Manhattan (New York County, 34.6%) and Brooklyn (Kings County, 7.8%); reports declined in the three other boroughs.

Meanwhile, the number of reported crimes in the Rest of the State – the 57 counties outside of New York City – reached a five-year low in 2018, with 146 reported.

The total number of hate crime incidents reported to police statewide in 2018 was small: 525 incidents, a fraction of all reported crime, which reached an all-time low in 2018. But because these crimes target individuals, groups of individuals or property based on a perception or belief about race, ethnicity, gender, sexual orientation, religion or other characteristic as defined by state law, they can adversely affect entire communities, not just their intended target.

Given this broader impact, New York State remains diligent in its efforts to prevent and respond to hate crimes and other forms of discriminatory behavior and bias through its Hate Crimes Task Force, led by the New York State Police with assistance from the state Division of Criminal Justice Services (DCJS) and state Division of Human Rights.

DCJS is required by law to annually publish a report analyzing hate crime incidents and arrests reported to the agency by police departments and sheriffs' offices through the Uniform Crime Reporting (UCR) system as of May 13, 2019. Dispositions of arrests are reported to DCJS by the courts. This report includes:

- Hate crime incidents by offense, bias motivation and demographic characteristics, such as age and gender of known offenders.
- Arrests made for offenses charged as a hate crime.

- Hate crime arrests that resulted in a criminal conviction or youthful offender adjudication annually from 2014 through 2018.
- Hate crime incidents reported annually from 2014 through 2018. These trends are detailed in the appendices to this report.

Major Findings

- ◆ Nearly 59 percent of the 525 reported hate crimes targeted property and 41 percent targeted people.
- ◆ Hate crimes against property (309) decreased 4.9 percent and crimes against individuals (216) decreased 8.1 percent.
- ◆ Consistent with prior years, the most frequently reported bias motivations for hate crimes against property were anti-Jewish (67%) and anti-black (13.6%).
- ◆ The most frequently reported bias motivations for hate crimes against individuals were anti-black (22.2%), anti-Jewish (20.8%), and anti-gay male (18.5%).
- ◆ There were 252 anti-Jewish incidents statewide, the second highest number reported in a decade.
- ◆ Most hate crime incidents involved criminal mischief (55.2%) and simple assault (30.3%).
- ◆ The most common hate crime arrest charges were aggravated harassment (41.7%) and assault (27.2%).

Reported Hate Crime Incidents

Under New York’s Hate Crime Law (Penal Law Article 485) a person commits a hate crime when a designated offense is committed targeting a victim because of a perception or belief about their race, color, national origin, ancestry, gender, religion, religious practice, age, disability or sexual orientation, or when such an act is committed as a result of that type of perception or belief. These crimes can target an individual, a group of individuals or public or private property.

Table 1 details hate crime incidents reported by Uniform Crime Reporting (UCR) categories, used by the FBI to allow for uniform reporting across all 50 states.

Appendix 4 details the New York State Penal Law crimes that correspond to the FBI’s UCR categories.

Investigating officers are responsible for identifying an offense as a hate crime and specifying the bias motivation when reporting the incident.

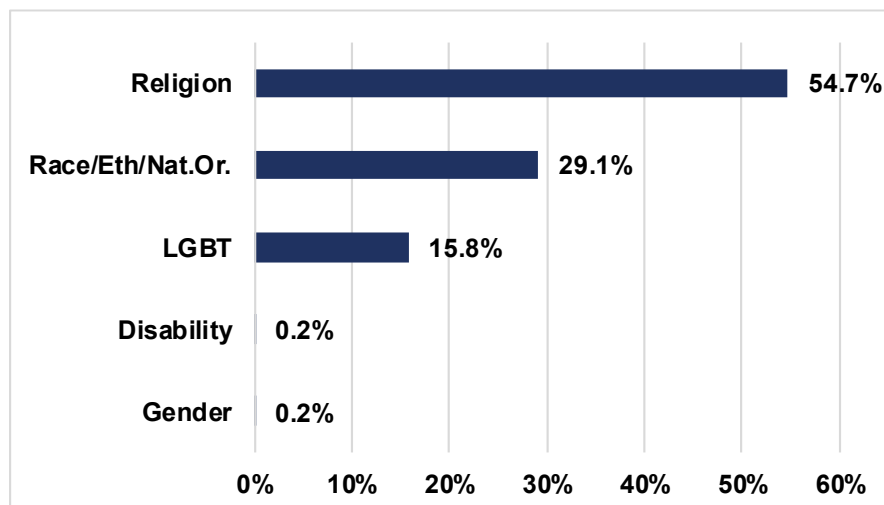
- Of the 525 hate crimes reported, 309 (58.9%) targeted property and 216 (41.1%) targeted individuals.
- Criminal mischief (290) accounted for 55.2 percent of all hate crimes and 93.9 percent of property crimes.
- Simple assault (159) accounted for 30.3 percent of all hate crimes and 73.6 percent of crimes against individuals.

- More than half — 54.7 percent — of all incidents involved an anti-religious bias, with 287 incidents reported.
- Race/ethnicity/national origin was the bias motivation in 153 incidents (29.1%).
- LGBT was the bias motivation in 83 incidents (15.8%).
- Five-year trends for all hate crime bias motivation types are detailed in Appendix 1.

Table 2. Bias Motivation by Offense Type 2018

Table 2 shows bias motivation for all hate crimes reported to police in 2018, as well as the bias motivation for each type of hate crime: crimes against individuals and property crimes.

- The most common bias motivation for all hate crimes was anti-religion, with 287 reported.
- In the anti-religion category, anti-Jewish crimes accounted for the overwhelming majority of those incidents: 87.8 percent (252 of 287).
- Anti-Jewish crimes accounted for 48 percent (252 of 525) of all hate crime incidents.
- Anti-black bias accounted for more than half (90 of 153) of the incidents involving anti-race/ethnicity/national origin bias and 17.1 percent (90 of 525) of all reported hate crimes.
- Anti-LGBT bias accounted for 15.8 percent of all reported hate crimes (83 of 525).

Crimes Against Persons

- Bias against race/ethnicity/national origin was the most common bias type in crimes against persons, with 94 incidents (43.5%) reported. This was followed by anti-religion, 62 incidents (28.7%), and anti-LGBT, 58 incidents (26.9%).
- Black individuals were the most commonly targeted group (48 of 216), followed by Jewish (45) and gay men (40).
- Within the anti-religion category, anti-Jewish bias accounted for 45 of 62 incidents (72.6%).
- The second most frequent religious bias was anti-Islamic, with those incidents accounting for 19.4 percent (12 of 62) reported crimes.

Property Crimes

- Of the 309 reported hate crimes targeting property, 72.8 percent (225) were motivated by a bias against religion,
- Bias against race/ethnicity/national origin accounted for 19.1 percent (59) of reported property crimes.
- Anti-Jewish bias was the most commonly reported bias in incidents targeting property: 67 percent (207 of 309) incidents.
- The second most common bias type was anti-black: 13.6 percent (42 of 309 incidents).
- Appendix 1 details five-year trends.

Offenders as Reported by Their Victims

Reporting of offender demographic characteristics by the victim or another party is often incomplete, partly due to the fact that some hate crimes involving property do not involve direct contact between the target and perpetrator.

At least one type of offender demographic — gender, age or race/ethnicity — was reported in 229 incidents. Those incidents involved a total of 249 offenders because a single incident can involve multiple offenders.

Table 3 presents the gender, age and race/ethnicity of offenders in those 229 incidents as reported by a victim or other party.

- The gender of 236 offenders was reported and the vast majority were male: 218 of 236 (92%).
- Age was reported for 167 offenders: 117 individuals (70%) were 39 years old or younger. The most common age range was 30 to 34 (29 offenders).

- Race/ethnicity of 221 offenders was reported: 43.4 percent black, 43 percent white, and 11.3 percent Hispanic. The race of 11.2 percent of offenders was reported as unknown.

Table 4 presents the number of offenders involved in the 229 hate crime incidents.

- The majority of the 229 incidents (94.3%) involved one offender.
- Two or more offenders were reported in 13 incidents (5.7%), for a total of 33 offenders involved.
- Of those 13 incidents, nine involved two offenders, two involved three offenders, one involved four offenders and one involved five offenders, the most reported for any one incident.
- The most common offenses involving known offenders were simple assault (133 or 53.4%) and aggravated assault (43 or 17.3%).

Unknown Offenders

- There was no information reported about the number of offenders involved in 296 of the 525 reported hate crimes.
- Of those 296 incidents, 261 (88.2%) involved crimes against property.
- The majority of incidents with unknown offenders were criminal mischief (255 or 86.1%).
- Of the incidents with unknown offenders, 65.2 percent (193) were motivated by anti-Jewish bias.

County of Reported Hate Crime Incidents and Arrests

Hate crime incidents and/or arrests were reported by police departments and sheriffs' offices in 38 of the state's 62 counties. Agencies reported no incidents or arrests in the remaining 24 counties; those counties are excluded from the table below.¹

Arrests represent a hate crime charge being brought at the time of the arrest, as reported to DCJS by the arresting agency. The number of reported hate crime incidents and arrests in a given year should not be compared: not all hate crime incidents in a given year result in an arrest; arrests can occur in a different year than the associated crime; and one incident can involve multiple offenders.

- Law enforcement in the five counties that comprise New York City — Bronx, Kings, New York, Queens and Richmond — reported 67 percent of all hate crime incidents in the state and made 64.5 percent of all hate crime arrests.
- In the Rest of the State, 65.8 percent of incidents were reported by law enforcement agencies from five counties: Suffolk (28), Westchester (21), Nassau (20), Albany (15) and Erie (12).
- Police departments or sheriffs' offices in four counties made one or more hate crime arrest, but reported no incidents: Steuben (two) and Chemung, Greene and Schenectady (one each).

¹ The following 24 counties reported no hate crime incidents or arrests in 2018: Cattaraugus, Chautauqua, Chenango, Columbia, Cortland, Delaware, Essex, Franklin, Fulton, Genesee, Hamilton, Jefferson, Lewis, Madison, Montgomery, Orleans, Otsego, Schuyler, Sullivan, Tioga, Warren, Washington, Wyoming and Yates

Note: The MTA (Metropolitan Transportation Authority) Police Department and NYS Park Police (New York State Park Police) serve multiple counties.

Hate Crime Arrests

New York State Penal Law Article 485 specifies the Penal Law offenses that can be charged as hate crimes.

Table 6 shows the most serious Penal Law offense charged as a hate crime for the 228 arrests made in 2018. Of those, 44.7 percent were offenses against public order and 34.2 percent were assault and related offenses.

The most common hate crime arrest charges were second-degree aggravated harassment (60), a misdemeanor; second-degree assault (40), a felony; and first-degree aggravated harassment (35), a felony.

This table also groups arrest charges by the corresponding Uniform Crime Reporting (UCR) category. As noted on Page 2, the FBI defines these categories.

Dispositions of Hate Crime Arrests

The processing of cases in criminal court often takes several months to complete and can result in a range of dispositions.

Dispositions by Crime Type

This section only details hate crime arrests that resulted in either a criminal conviction or youthful offender adjudication² for the five-year period from 2014 through 2018. The term adjudication is used in cases involving youthful offenders because the case is sealed and details of the case are not permitted to be disclosed, except under limited circumstances defined in state law.

The courts reported 392 convictions and youthful offender adjudications to DCJS between 2014 and 2018.

Table 7 details crime type (felony or misdemeanor) and notes whether the conviction or youthful offender adjudication was for a hate crime or another Penal Law crime.

- There were 392 dispositions reported: 238 resulted in criminal convictions to misdemeanors, 115 to felonies and 39 youthful offender adjudications.
- Of the total dispositions, 117 (29.8%) resulted in convictions or youthful offender adjudications to hate crime offenses.
- The remaining 275 dispositions were for offenses not designated as hate crimes.
- Of the 275 non-hate crime dispositions, 72 (26.2%) were felony convictions and 176 (64%) were misdemeanor convictions.

Disposition Charges

Table 8 shows the most serious charge for the 392 convictions and youthful offender adjudications, as reported for the five-year period from 2014 through 2018.

These charges are grouped by FBI UCR categories.

- Of all dispositions, 64 percent involved crimes against individuals (251). The majority of these convictions were categorized either as simple assault (188) or aggravated assault (45).
- Property crime offenses were involved in 25.5 percent of dispositions. The most common property crime dispositions were categorized as either criminal mischief (57) and larceny (25).
- Disposition charges by New York State Penal Law are detailed in Appendix 5.

² Offenders who are age 16 through 18 at the time of their crime may be adjudicated as youthful offenders (see Criminal Procedure Law 720.10). A youthful offender (YO) adjudication broadens sentencing options and seals the criminal record.

Sentences for Convictions and Youthful Offender Adjudications

Table 9 presents the type of sentence imposed by the courts for the 392 convictions and youthful offender adjudications*.

A sentence to jail was the most common imposed by the court, with nearly one-third (32.1% or 126) reported. Of the remaining sentences:

- 91 (23.2%) were conditional discharges,
- 68 (17.3%) were to state prison, and
- 62 (15.8%) were to local probation.

*Youthful offender adjudications are sealed but individuals can serve any of the sentence types noted.

Reported hate crimes decreased by 6.3 percent when comparing 2018 to 2017. A five-year high of 598 incidents was reported in 2016.

Crimes against individuals decreased by 8.1 percent and crimes against property decreased 4.9 percent, when comparing 2018 to 2017.

The 216 incidents reported against individuals in 2018 was the lowest during the five-year period.
