The eToro platform is operated by multiple eToro entities, including eToro USA LLC (cryptocurrency trading) and eToro USA Securities Inc. (stocks, ETFs, and options trading). eToro USA LLC is a money services business registered with the Financial Crimes Enforcement Network (FinCEN). eToro USA Securities Inc. is a broker-dealer registered with the Securities and Exchange Commission (SEC) and is a member of the Financial Industry Regulatory Authority (FINRA) and the Securities Investor Protection Corporation (SIPC).

Customers may fund their main platform accounts (stock, ETF, options, and cryptocurrency trading) by transferring funds to eToro USA LLC. Funds are then transferred to other firms to purchase the relevant investments (Apex Clearing Corporation, which is eToro's securities clearing broker, to purchase stocks/ETFs and options; eToro USA LLC's affiliates outside of the US for cryptocurrency purchases). Customers with options trading accounts can also transfer funds between their eToro USA LLC account and their eToro Options account (offered by eToro USA Securities Inc. and Apex).

Customers can also fund their eToro Options account through a separate eToro Options mobile app by depositing funds to their options trading account maintained at Apex Clearing Corporation through eToro USA Securities Inc.
